1. National Sports University at a glance

1.1 INTRODUCTION

The National Sports University, Manipur was set up in 2018, with a tentative project cost of over Rs.500 crores. The University is presently functional from its temporary campus at the KhumanLampak Sports Complex, Imphal. Prime Minister Shri Narendra Modi has already laid the foundation stone for the University's proposed 325 acre campus at Imphal West, on 16th March 2018. Dr. Najma Heptulla, Governor of Manipur, Shri N. Biren Singh, Chief Minister, Manipur, Col. Rajyavardhan Rathore (Retd.), AVSM, Minister of State (Independence Charge) Youth Affairs & Sports were also present on the occasion of laying of Foundation Stone of the University. The construction work is underway at the proposed site.

A state like Manipur which has produced many sportspersons of international repute, more than deserves a state-of-the-art sports university which will further give the much-needed push to produce more prodigies.

India already has several state universities focusing on sports education including a Deemed University. But NSU is the first Central University to be set up in India with the objectives of focusing on sports education and producing top athletes, sports scientists, and physical educationists.

The National Sports University will have the flexibility to open new schools/departments in consonance with the advances and developments in sports science, sports medicine, and allied areas.

The University, once developed, will be the first one of its kind to promote sports education in the areas of sports sciences, sports technology, sports management, and sports coaching. It will also function as the

national training centre for selected

School of Sports Education having departments of Physical Education, Sports Coaching and allied sciences.

School of Interdisciplinary Studies having departments of Languages, Sports Sociology, Peace and Development, etc.

International Partners: In addition to forging partnerships with national institutions within the national sporting system, external partnerships shall be sought to bring in specific expertise and to ensure achievement of high performance in sports. International collaborations in the form of Memoranda of Understanding and bilateral cooperation agreements are essential as they would enable NSU, Australia, Nippon and Tsukuba Universities in Japan, University of Cologne in Germany.

A well-planned road map and the modalities of linking NSU with various other institutes / universities will be chalked out in due course of time.

2.2.2 BACHELOR of Physical Education and Sports (BPES)



Testing Areas:

The written test shall comprise of Multiple Choice Questions (MCQs) or Objective Type Questions from General Awareness, Sports Awareness, Sports General Knowledge, and Reasoning.



Note: 1. The Test will be of 70 marks and the duration of the test is 90 mins. 2. The questions will be objective in nature.



3. Admission to National Sports University

The Admission Rules as framed by the University from time to time, shall be applicable for all admissions. All decisions taken by the University in this regard shall be final. The candidates are advised to go through the instructions given in the Admission Application Form as well as in the Prospectus before submission of application.

For the commencement of any programme - UG or PG - a minimum of 5 students is mandatory. In the absence of 5 students, the fee will be refunded to the student and the programme will not be launched.

Admission to various programmes of NSU will be done only once in an Academic Year, through its own admission test, National Sports University Admission Test.

3.1 General Instructions for AdmissionTest:

The candidates appearing for Admission Tests to undergraduate and postgraduate programmes shall keep the following points in mind:

- Call Letter: Candidates will NOT be sent a Call Letter for the Admission Test by post. Call Letters shall be downloaded from the University website. Candidates are advised to check their email regularly.
- ii. Ineligible Candidates: Candidates not meeting the stipulated guidelines elucidated in the Eligibility Criteria for specific programmes shall not be eligible to appear in the Admission Test.

- iii. Admission Test Score: He/she should have scored at least 45% marks in the Admission Tests conducted by the University, the particulars of which are provided under the section titled.
- iv. Medical Fitness Test: Once the result of the Admission Test is declared, the selected candidates shall undergo a detailed Medical Examination conducted by a board of medical doctors constituted by NSU.
- v. Medical Fitness: He/she must be medically fit and free from physical deformities and must be approved by any Government Medical Officer.
- vi. Payment of Fees: Please note that the candidate shall remit tuition and hostel fee only after the candidate has been issued a 'Medically Fit' slip. The candidate shall present the slip at the time of payment of fee.

4. Application for Admission

4.1 How to Apply for Online Admission

- Online Availability of Admission Details: The admission details are available in the Prospectus of the University, available on the website of NSU, www.nsu.ac.in. After going through the prospectus, and online instructions, the candidate can register himself/herself on NSU's website and apply online for the course of his/her choice. No offline mode is available for applying.
- 2. If any candidate is applying for more than one Course, they should register separately and submit another application form.
- 3. Eligibility to apply: A candidate who wishes to apply for any of the programmes offered by NSU, Manipur, may read the eligibility criteria and general conditions for admission and satisfy himself/herself about his/her eligibility to apply. Eligibility criteria for each courses are given in the Para 2.1.1, 2.1.2, 2.2.1 and 2.2.2 of the Prospectus.
- Apply Provisionally: If you have appeared in a qualifying examination and the result thereof is awaited, you can apply. However, Admission will be subject to meeting the eligibility criteria on the date of admission.
- 5. Online Application Fee: The online application fee is Rs. 500/- per course.
- Note: The cost of online application shall not be reimbursed under any circumstances.
- 6. Candidates with Disabilities: For persons with disabilities, admission is not open for the following courses:

4.2 Admission and Reservations

4.3 International Athletes & Achievers

International athletes are eligible for Direct Admission to all the undergraduate and postgraduate programmes offered by NSU provided that they have participated in Olympic Games, Asian Games, Commonwealth Games, South Asian Games, Youth Olympics, Commonwealth Youth Games, Asian Youth Games, World Championships, Asian Championships, and Commonwealth Championships in the disciplines included in Olympic Games, Asian Games, and Commonwealth Games, provided they fulfill the minimum educational eligibility criteria. Tuition fee waiver for athletes who have participated in international competitions may be considered for admission based on their participation / achievement in such events during the last three years.

4.4 Women Candidates

- (a) Married girl is eligible for admission.
- (b) In the event of a married student conceiving during the course, she shall discontinue her studies for at least one academic year.
- (c) She may re-join the same course afresh from the beginning of the semester she had discontinued her studies, provided the University guidelines pertaining to the maximum duration of the course is adhered to.
- (d) Under no circumstances will she be permitted to keep the infant along with her in the Hostel.

4.5 Counselling

4.5.1 Provisional Admission through Counselling

- A candidate does not become eligible for admission solely based on his/her marks in the Qualifying Examination and/ having scored the minimum percentage in the various segments of Admission Test.
- The provisional list of selected candidates for admission to the various programmes offered by the University, from among those who have been successful in the Admission Test, shall be compiled through the process of counselling.

4.5.2 Eligibility to Appear for Counseling:

- a. The eligibility of candidates to appear in for Counselling shall be declared in their respective categories, based on the declarations made by the candidates in their application forms, which shall be purely provisional in nature. Therefore, the candidates are advised to fill-in the Admission Application Form with care.
- b. If a candidate claims that he/she belongs to a reserved category in the Admission Application Form but fails to submit documents supporting the claim to the satisfaction of the University at the time of admission, then his/her Provisional Selection to that category shall stand cancelled automatically.
- c. The provisionally selected candidates shall be required to undergo a Medical Test to be conducted by the University*. The final list of selected candidates shall be made based on the basis of the list of medically fit students submitted by a panel of doctors constituted by the University for the purpose.

This clause is subject to change based on the situation prevailing at the time of Admission Test.

5. Admission Process

5.1 General Conditions for Admission

Any candidate wishing to apply for admission to any of the programmes offered by the University shall familiarize himself/herself with the general conditions enumerated herein.

- a) Medium of Examination: The medium of examination shall be either Hindi or English for undergraduate courses and English for PG courses.
- b) Character of the Candidate: Candidates expelled from any other Board/ Institute/University or dismissed from Government service on disciplinary grounds and those who are known to have been involved in acts of crime and gross indiscipline or misconduct will not be



furnished by them. If, at any time, it is noticed that the admission has been obtained by giving incorrect or false information or concealing information or oversight, the admission granted will be cancelled and the candidate shall be asked to leave the University.

 d) Submission of Mandatory Documents: Once the counselling is over and the candidate is selected for a programme, he/she shall, at the time of securing admission, within the time stipulated for the purpose, submit attested copies of the



eligible for admission. The University may approach the police for verification in this regard. After admission, at any time of the on-going programme, if a student is found guilty in this regard, his/her admission will be canceled without any notice.

 c) Furnishing False Information: Admission will be granted to the candidates at their own risk and responsibility as per details following mandatory documents along with the original documents (for verification):

- i. Marksheet of the qualifying examination.
- Proof of date of birth (Marksheet of Secondary / Senior Secondary Examination).



- iii. Character/Conduct Certificate from the Institute/College/University last attended.
- iv. Anti-Ragging Affidavits by the candidate and his/her parents, notarized by the Notary Public, in the prescribed format, provided in Annexures III(A) & III(B).
- v. Bonafide Certificate testifying the candidate's SC/ST/OBC status, if applicable, in the prescribed format as given in Annexures IV & V (A).
- vi. Candidates claiming reservation in the OBC Category are to submit a

- viii. Declaration in the prescribed format given in Annexure VII about the Medical Fitness of the Candidate by Self and Parents, at the time of admission.
- ix. Sports achievement certificates
- e) Failure to Submit Mandatory Documents: Candidates who fail to submit the mandatory documents by the stipulated date, even after securing a position in the merit list among the provisionally selected candidates, shall not be eligible for admission.
- f) Payment of Tuition, Uniform & Hostel Fees: The finally selected candidates shall be required to pay the fee as mentioned in the fee structure for UG and



Declaration regarding Non- creamy Layer in the prescribed format specified in Annexure V (B).

vii. Transfer Certificate & Migration Certificate fromthe Board/Institute/College/University last attended. Format is provided in Annexure VI. PG students under Annexures-VIII (A), (B) &(C) respectively. In case any selected candidate fails to deposit the fee within the stipulated period, his/ her admission shall stand cancelled and other candidates from the Waiting List shall be admitted through counselling.

6. Sexual Harassment

6.1 Section 3(1) of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal)Act, 2013:

The Act recognises the right of every woman to a safe and secure workplace environment irrespective of her age or employment/status.

6.4 What constitutes Sexual Harassment?



"Sexual Harassment" includes anyone or more of the following unwelcome acts orbehaviour (whether directly or by implication), namely:

- a) Physical contact or advances;
- b) Ademand or request for sexual favours;
- c) Showing pornography;
- d) Any other unwelcome physical, verbal, or



6.2 Who are protected?

The right of all students and women working or visiting any workplace in the capacity of regular, temporary, ad hoc, or daily-wages basis is protected under this Act.

6.3 What is a Workplace?

A workplace under this Act includes among other places of work including any sports institute, stadium, sports complex, or competition or games venue, whether residential or not used for training, sports, or other activities relating thereto. non-verbal conduct of a sexual nature.

Some examples of behaviour that constitutes sexual harassment are given below:

- a) Making sexually suggestive remarks or innuendos;
- b) Serious or repeated offensive remarks, such as teasing related to a person's body or appearance;
- c) Offensive comments or jokes;
- d) Inappropriate questions, suggestions, or remarks about a person's sex life;



e) Displaying sexist or other offensive pictures, posters, MMS, SMS, Whats App, or e-mails;

- f) Intimidation, threats, blackmail around sexual favours;
- g) Threats, intimidation, or retaliation against an employee who speaks up about unwelcome behaviour with sexual overtones;
- h) Unwelcome social invitations, with sexual overtones commonly understood as flirting;
- i) Unwelcome sexual advances which may or may not be accompanied by promises or threats, explicit or implicit;
- j) Physical contact such as touching or pinching;
- k) Caressing, kissing, or fondling someone against her will that could be considered assault;
- Invasion of personal space like getting too close for no reason, brushing against or cornering someone;
- m) Persistently asking someone out, despite being turned down;
- n) Stalking an individual;
- o) Abuse of authority or power to threaten a person's job or undermine her performance against sexual favours;
- p) Falsely accusing and undermining a person behind closed doors for sexual favours;
- q) Controlling a person's reputation by rumour-mongering about her private life.

6.5 How to Recognize Sexual Harassment?

It is important to remember that sexual harassment is sexual, unwelcome, and the experience is subjective. It is the impact and not the intent that matters. A sexual

harassment experience may be a single instance or a series of incidents over a period of time.

6.6 Constitution of Internal Complaints Committee

- (a) The Vice-Chancellor shall, by an order in writing, constitute an "Internal Complaints Committee," consisting of the following members:
 - i. Presiding Officer, who shall be of the rank of a professor or associate professor;
 - ii. not less than two members from amongst the faculty members preferably committed to the cause of women or who have had experience in social work or have legal knowledge;
 - iii. one member from amongst nongovernmental organizations or associations committed to the cause of women or a person familiar with the issues relating to sexual harassment;

- iv. at least one-half of the total members so nominated shall be women.
- (b) The Presiding Officer and every Member of the Internal Committee shall hold office for a period not exceeding three years, from the date of their nomination.
- (c) Where the Presiding Officer or any member of the Internal Committee,
 - i. contravenes the provisions of Section 16 of the Act; or
 - ii. has been convicted for an offence or an inquiry into an offence under any law for the time being in force is pending against her/him; or
 - iii. she/he has been found guilty in any disciplinary proceedings or a disciplinary proceeding is pending against her/him; or
 - iv. has so abused her/his position as to render her/his continuance in office prejudicial to the interest of the University community, such Presiding Officer or Member, as the case may be, shall be removed from the Committee and the vacancy so

created or any casual vacancy shall be filled by fresh nomination.



6.7 Complaint of Sexual Harassment

The procedure for making complaints against sexual harassment shall be as follows:

- i. Any aggrieved woman may make, in writing, a complaint of sexual harassment at workplace to the Internal Committee within a period of three months from the date of incident and in case of a series of incidents, within a period of three months from the date of last incident.
- ii. In cases where such complaint cannot be made in writing, the Presiding Officer or any Member of the Internal Committee, as the case may be, shall render all reasonable assistance to the woman for making the complaint in writing.
- iii. The Internal Committee may, for the reasons to be recorded in writing, may extend the time limit not exceeding three





months, if it is satisfied that the circumstances were such which prevented the woman from filing a complaint within the said period.

- iv. Oral Complaints are to be lodged in person or by a person accompanying the victim before the Chairperson or to any member of the Committee.
- v. All oral complaints when made, shall be reduced in writing by the Presiding Officer or a person designated and signed by the victim and person accompanying the victim.

mental incapacity or death or otherwise, her legal heir or such other person as may be prescribed may make a complaint.

- ix. The mechanism for registering complaints should be safe and sensitive.
- The Committee shall maintain complete confidentiality of the entire proceedings. Only such a Committee will provide the needed courage, comfort and trust for someone to make a complaint.
- xi. Any faculty, staff, or student who comes to know about an incident of harassment



- vi. In exceptional cases, third party complaint may be entertained subject to confirmation by the victim on call.
- vii. Anonymous complaints, would, in general, not be taken up by the Committee for action. However, the content of such complaints may be used for sensitization purposes, if deemed relevant.
- viii. If the aggrieved woman is unable to make a complaint on account of her physical or

shall advise the affected person to approach a member of the Committee or report to a member themselves.

xii. The Internal Committee may, before initiating an inquiry, at the behest of the aggrieved woman, take steps to settle the matter between her and the respondent through conciliation provided that no monetary settlement shall be made as a basis of conciliation.



- xiii. The Internal Committee shall have the power to
 - a) summon and enforce the attendance of any person and examining him under oath;
 - b) require the discovery and production of documents; and
 - c) any other matter which may be deemed necessary.
- xiv. The said inquiry shall be completed within a period of ninety days.
- xv. The Internal Committee shall provide copies of the settlement to the aggrieved woman and the respondent.

6.8 Inquiry Report

- a) On the completion of an inquiry, the Internal Committee shall provide a report of its findings to the Registrar/Vice Chancellor, within a period of ten days from the date of completion of the inquiry and such report shall be made available to the concerned parties.
- b) Where the Internal Committee arrives at the conclusion that the allegation against the respondent has not been proved, it shall recommend to the Registrar/Vice Chancellor that no action is required to be taken in the matter.

c) Where the Internal Committee arrives at the conclusion that the allegation against the respondent has been proved, it shall recommend –



- I. suitable action as per the provisions of the Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act 2013.
- ii. suitable action to be taken for sexual harassment as a misconduct in accordance with the provisions of the rules of the University;
- iii. suspension from the University or removal of the name of the respondent from the rolls of the University, depending on the gravity of the crime;
- iv. debarring the respondent from appearing in the examinations; or
- v. any other punishment that shall be deemed suitable.

6.9 Punishment for False Complaint and False Evidence

- a) If, on conducting inquiry, the Internal Committee arrives at a conclusion that the allegation against the respondent is malicious or the aggrieved woman or any other person making the complaint has made the complaint knowing it to be false or the aggrieved woman or any other person making the complaint has produced any forged or misleading document, action may be taken against the woman or the person who has made the complaint.
- b) Mere inability to substantiate a complaint or provide adequate proof thereof need not attract attention against the complainant.



7. Other Student Rules

2.1 Refund of Fee & Caution Deposit:

a) Refund of fee to the students shall be regulated as per the UGC norms as revised from time to time.

b) Refund of Caution Deposit, if due, shall be made by the University only after the declaration of the final result of the Programme, on production of No Dues Certificate.

7.2 Attendance Rules:

- a) The University expects 100% attendance from the students in each subject/activity/ area of the total curriculum.
- b) If a student has to be absent from class by availing leave on grounds like medical, social engagements, personal, etc., a relaxation of 15% shall be given.
- c) In exceptional and deserving cases, the competent authority may grant further relaxation not exceeding 10% in attendance.
- d) The students shall ensure that he/she has at least 85% attendance, at least one month prior to the date of commencement of semester examinations.

7.3 Code of Conduct:

Students pursuing studies at the University are expected to be familiar with the Rules and Regulations provided in the Admission Prospectus.

- i. Students shall conduct themselves in an exemplary manner so as to be a model for other students.
- ii. All students should strictly adhere to the Rules and Regulations of the University.

- iii. All students should be present for classes (activity & theory) on all working days and sincerely apply themselves to studies.
- iv. Students should attend classes regularly and punctually so as to fulfill the attendance requirement of 75% as prescribed by the University, to be eligible to appear for the University examinations.
- v. The Campus is "Tobacco Free" and "Alcohol Free". Any violation of this will result in dismissal from the programme.
- vi. Use of mobile phones and other electronic gadgets are not permitted in classrooms, examination halls, faculty premises, and at the venue of programme sorganised by the University.
- vii. Students are forbidden from using motorized vehicles, including powered two-wheelers, inside the Campus.
- viii. Students are advised to visit notice boards set up at different places in the Campus, regularly to know about matters pertaining to academics and other activities.

7.4 Dress Code:

The students shall adhere to the prescribed dress code of the University.

7.5 Ragging:

- a) Ragging is strictly prohibited within and outside the University.
- b) If any student is involved in ragging or any other anti-social activities, he/she shall be expelled and criminal proceedings may be initiated against him/her.
- c) For further details regarding the University Rule's and Regulations on ragging, please refer Student Handbook.

8. Sports Equipment:

All students are required to procure personal sport equipment as specified for various games/sports, on their own.

9.Clothing & Other Requirements:

The summer temperature at Imphal, Manipur ranges from 32°C to 34°C, and from 1°C to 2°C in winter. The students are advised to bring appropriate bedding and clothing.

10. Award of Degree:

On successful completion of the programme and examination as per the requirements prescribed under the Rules/Scheme of Examination of the University, a student shall be awarded degree.
