#### General Guidelines for Scholarship

#### I. University Scholarships

- i. National Sports University awards scholarships to its Under-graduate and Postgraduate students to promote and recognize academic and sports excellence, and overall growth and development of meritorious students who have passed their respective qualifying examinations.
- ii. Scholarships shall be awarded to undergraduate and post graduate students based on the recommendations of the <u>University Scholarship Committee</u> (USC) and on approval of the Vice-Chancellor.

# III. The following University scholarships will be awarded:

## 1. University Merit Scholarship (UMS):

UMS is available for Under-graduate and Post-graduate students of the University. The scholarship is meant for the year-wise class toppers of each streams and is awarded from the second year on the recommendations of the University Scholarship Committee

#### Eligibility Criteria:

The student has to complete without any break:

- a. I and II semesters for the second year scholarship. (For BPES, B.Sc.SC, MA.SP, MPES and M.Sc.SC)
- b. III-IV semester for the third year scholarship (for BPES, B.Sc.SC).
- c. V-VI semester for the fourth year scholarship (B.Sc.SC students only).
- ii. The student should have cleared all the courses of the concerned semesters in the first available chance.
- iii. The student should have secured the highest yearly performance in the semesters taken for reckoning, with a minimum benchmark of 60% or equivalent to 6 CGPA
- iv. The student should not have been awarded any disciplinary action imposed by the university.
- v. **Period of scholarship**: The scholarship is given for a period of two semesters: July-November and January-May covering 10 (ten) months in total i.e. the grant of scholarships is for a period of one year at a time.
- vi. Value: Rs. 10.000/- .

# 2. <u>University Merit-cum-Means Scholarship(UMcM):</u>

University merit-cum-means scholarship is awarded to Under-graduate and Post-graduate students of the University. The scholarship is strictly on merit-cum-means year wise basis and on the recommendations of the University scholarship committee

# i. Eligibility Criteria:

- a. Parents' income should not exceed the prescribed limit per annum.(prescribed income limit is subject to Govt. notifications and is currently Rs. 6.00 lakhs per annum)
- b. Students with minimum of 60% or equivalent to CGPA 6.00 (year-wise) are eligible to apply.
- c. The student should have cleared all the courses of the concerned semesters in the first available chance.
- d. The student should not have been awarded any disciplinary action imposed by the university
- ii. **Period of scholarship**: Eligible student will receive the scholarship for a period of two semesters: July-November and January-May covering 10 (ten) months in total.i.e. the grant of scholarships is for a period of one year at a time.
- iii. Value: Rs. 10,000.00
- Number of Scholarship: 6 numbers (2 each for undergraduate and 2 for postgraduate based on the CGPA of eligible students from previous academic year)

#### 3. University Sports Merit Scholarship(USMS):

University Sports Merit Scholarship up to 5% of the sanctioned strength under-graduate and post-graduate students will be award to medal winner at All India Inter-University and National Level Competition held individual events and team sports during the previous year achievement.

Medal winners only in the events/sports/games including in the schedule of All India Inter University Sports Control Board or Indian Olympic Association or the list recognised by the National Sports Federations concerned will be considered for the award of scholarships.

Sports achievement rating scale will be decided by the University Scholarship Committee and will be applied to decide the order of merit for the scholarship. In case of a tie on a particular point of merit, the number of achievement/participation in the game /sport at different levels and the number of merit certificates possessed by the students will be considered in order.

- Period of Scholarship: Scholarship will be awarded for a period of two semesters (July-November and January-May)i.e.the grant of scholarships is for a period of one year at a time.
- II. Value: The value of USMS shall be Rs.10000.00, Rs.7000.00 and Rs.5000.00 for gold, silver and bronze medal winner respectively.

Freeship for the entire course to be given to students who participated and won a medal in the International level championships under University Sports Merit Scholarship (USMS).

Freeship for 1(one) year to be given to the students who participated in the International level championships and games.

# IV. Scholarship will be recommended by the University Scholarship Committee (USC) based on the following guidelines.

- 1. Scholarships are liable to be withdrawn in case of misconduct, deliberate concealment of material facts and/or supply of false information.
- 2. Students leaving the University on their own accord without completing the programme of study may be required to refund the amount of scholarship received during that year.
- 3. During the tenure of the scholarship, the scholarship holder shall not ordinarily receive any other scholarship, stipend, financial assistance or remuneration etc., for any work except with the prior permission of the competent authority or as provided in the guidelines.
- 4. The students selected for scholarship shall not accept or hold any appointment, paid or otherwise, and will not receive any emoluments, salary, etc. from any other source during the tenure of scholarship.
- The scholarship may be suspended or terminated at any time on the grounds of misconduct on the part of the student concerned or on continued absence for more than one month except on medical grounds.

# V. Other Scholarships:

- 1. During the tenure of the scholarship, the scholarship holder shall not ordinarily receive any other scholarship, stipend, financial assistance or remuneration etc., for any work except with the prior permission of the competent authority or as provided in the guidelines.
- 2. The University may accept donations from individuals and organizations to set up scholarships according to prescribed procedures if it is felt that they will promote academic activities in the university and will lead to general growth of the university. The norms and conditions for the University of such scholarships shall require approval of the Executive Council on the recommendation of the Academic and Activity Council.
- 3. A student can avail not more than two scholarships one merit/merit cum mean scholarship and other in sports merit scholarship awarded by National Sports University.
- 4. In case of any difficulty in operating any clause of this guideline the matter shall be referred to the Vice-Chancellor whose decision thereon shall be final.
